CHATSWORTH, BURWASH ROAD, BROAD OAK, HEATHFIELD TN21 8UG. Change of use of agricultural barn to training use and change of use of adjacent land to mix of training use and agriculture

**OBSERVATIONS:** The Committee objected to the application for the following reasons:

The driveway is unsuitable and inappropriate for large vehicles;

Inappropriate development for an Area of Outstanding Natural Beauty;

Working 6 days a week is inappropriate for a residential area in an AONB;

The access isn't suitable for having an increased number of vehicles; and

Environmentally unsuitable for an increased number of vehicles on site.

TAYLORS, WARREN CLOSE, CROSS IN HAND, HEATHFIELD TN21 OTD. Demolition of existing dwelling, garage and outbuilding and erection of four bedroom dwelling with three bay garage

**OBSERVATIONS:** The Committee objected to the application as they feel that it is out of character and not sympathetic with the surrounding area of Lions Green houses, it is overdevelopment of the site and isn't suitable for an Area of Outstanding Natural Beauty. They also feel that the small window above the garage, that overlooks the house opposite, should not be included in the application as it impinges on their neighbours' privacy.
