**WOODLAND BURIAL GROUND TABLE OF FEES - 2023**

\*Parishioners are defined as part of your Council Tax which is paid to Heathfield and Waldron Parish Council

\*\*Non Parishioners are defined as people who have moved outside the Parish more than 18 months ago.

Interment of a stillborn child, or a child whose age at the time of death did not exceed 3 years	No charge	£120
Interment of a child whose age at the time of death was more than 3 years and less than 18 years	£50	£180

**\*\*\*Reservations for a plot in the Woodland Burial Ground can be made but this would not be for a certain area. A plot would be identified at the time of interment.**

**WOODLAND ASHES PLOTS AT THEOBALDS GREEN**

Exclusive Right of Burial (75 years)	£160	£320
Interment – one cremated remains	£205	£410
Second cremated remains at the same time	£195	£390
Re-opening a grave for interment of each subsequent cremated remains	£195	£390
Interment of a stillborn child, or a child whose age at the time of death did not exceed 3 years	No charge	£60
Interment of a child whose age at the time of death was more than 3 years and less than 18 years	£40	£120
Scattering of ashes in the Woodland Burial Ground	£50	£150
Transfer of Exclusive Right of Burial	£15	£15

**Reservations are not taken for the Ashes Section of the Woodland Burial**

**No memorials are allowed in the Woodland Burial Ground this includes the Ashes section. In line with the Children’s Fund for England burial authorities can claim back fees incurred for a child who was stillborn after 24 weeks of pregnancy and was under the age of 18 years of age.**
